PRIVACY POLICY (hereinafter - Policy)

1. Terms, definitions and general provisions

- 1.1. **Site** www.belprodco.ru (hereinafter the Site).
- 1.2. **Administration / Site owner** means Limited liability company «Belarusian Production Company» (Taxpayer Identification Number (INN) 6732009595, Primary State Registration Number (OGRN) 1116732000329, Legal address: 34 Ochakovskoe shosse, floor 6, bldg. XI, apt. 26 (part) Moscow 119530, Russian Federation).

1.4. User personal information:

- 1.6. Generally the Site does not verify the accuracy of the personal information provided by the Users and does not exercise control over their legal capacity. However, the Site assumes that the User provides reliable and sufficient personal information on the issues proposed in the forms of the Site, and keeps this information up to date.

2. Purposes of collection and processing of personal information of users
